Amar Singh College

Amar Singh College (Urdu: امر سنگھ کالج سرینگر) in Srinagar, is an academic & professional college in Kashmir. It is the second oldest college in the Kashmir Valley after Sri Pratap College.

It was established in November 1913[1] as Amar Singh Technical Institute, to teach willing students art, culture, and basics like masonry and carpentry. It was formally opened on 29 May 1914 by Maharaja Pratap Singh. In June 1942, the Technical Institute was converted into Amar Singh College through bifurcation of Sri Pratap College commemorating the name of the father of Hari Singh, the then Maharaja of Kashmir. The College was recognized by University Grants Commission of India (UGC) in June 1972. The College is accredited by National Assessment and Accreditation Council [NAAC] with B++ Grade. The college is located in Gogji Bagh, in the city of Srinagar (74o-48`N latitude, 34o-03`E longitude and 1589m altitude). It is spread over 35 hectares of land divided into a large playground, parks, gardens, and an infrastructural area. The college has been recognized by higher education department as Research Hub for "Languages and Fine Arts" and "Interdisciplinary Research Ecosystem".

At present, the college has multiple academic buildings making a total built-up area of about 30000m². This includes the glorious heritage building, representing the finest blend of Anglo-Indian architecture, constructed in 1910 for running a technical institute. Presently it houses chemistry department, teaching staff room, UGC, IQAC Cell, NSS and NCC rooms, besides having six lecture theaters and three large halls for the conduct of examinations. The heritage building had got damages during earthquake in 2005 and devastating flood in September 2014. However, it was repaired and restored to its actual look in 2017-18 by J&K Government through INTAC.

Amar Singh College, the winner of the Award of Merit by UNESCO for 2020 Asia-Pacific Award for Cultural Heritage Preservation, is one of the oldest and most prestigious Institution of Higher Education of Kashmir Valley, with a legacy of upholding our traditions and culture while at the same time facilitating our students with the most recent trends in education.

The college offers Undergraduate and Postgraduate/integrated programs, and is the School of Humanities and Liberal Arts of Cluster University Srinagar. It is also the Hub College for Interdisciplinary and Multidisciplinary Research in Languages and Liberal Arts.

Shillong Law College

The Shillong Law College was established in the year 1964 as an Evening College. The Shillong Law College is registered under the Societies Registration Act, No. XXI of 1860. The College has been enlisted under Section 2 (f) and 12 (B) of the UGC Act, 1956 and has also been recognized by the Bar Council of India. Initially, the College was affiliated to Guahati University. In the year 1973 when North Eastern Hill University was established, the College came under the North Eastern Hill University and was granted Permanent Affiliation in 2007.

At present the College is imparting 3 Year LL.B Course and 5 Year B. A LL.B Course. Thousands of students have passed out from this College and many of them are in high positions in various parts of the country in various capacities including Hon'ble Judges of the High Courts, Advocate General & Additional Advocate General of the State. One of the former teachers of the College Shri S N Phukan has scaled to the high office of the Chief Justice of the High Court of Himachal Pradesh and later became Judge of the Supreme Court of India. Justice Home Choudhury of Gauhati High Court, Justice A.P. Subbah of Gauhati High Court, later of Sikkim High Court and Justice B. Lamare of the Gauhati High Court were the Students of the College. At present Hon'ble Justice S.R. Sen of the High Court of Meghalaya and Justice Nelson Sailo of Gauhati High Court were the shining products of this College and several of them have held the posts of Registrar General of High Court of Meghalaya and so also as the District & Session Judges, Additional District and Session Judges, Asst District Session Judges and Judicial Magistrate.

Smt Narsamma Arts Commerce and Science College

In the year 1995 the college began its UG classes with 165 students with 3 courses in a small rented building. Now more than two decades after, we have over 800 students, 8 courses and 28358 square feet of buildings spread over 10.25 acres of sprawling campus. The College started with a vision to bring to this economically underdeveloped region, contemporarily relevant and modern courses and subjects. Environmental Science, Industrial Chemistry and Industrial Microbiology were some of the new subjects introduced to the Amravati University region exclusively by this college. In the coming years, number of other colleges followed us. It is one of the many ways this college has shown a pioneer's vision.

The college is located mostly in the lower middle working class locality. So most of our students come from socially and

economically disadvantaged background. Despite having their entry-level percentage very low, many of our students have done exceptionally well in the fields of academics, sports as well as performing arts. The average aggregate result of B.Sc. has been more than 60% for the last 20 years. Number of our students have been placed in leading positions in the globally renowned corporations and the state and Central government organizations.

The College has 13 departments spread through 3 faculties of Arts, Commerce and Science. The college has 05 recognised research centers for PhD programs. 14 research scholars are working for their Ph.D. in these laboratories. Of the 28 full time teachers, 23 have received Ph.D. and 04 are working towards it.

St. John's College of Arts and Science

St. John's College of Arts and Science is a dream come true for the disadvantaged people along the coastline of Kanyakumari District. Rev. Frs. V. John Bosco and Albin Roby, the founders of this college, have been the trustees of the JVDC Trust (Jan Vriend Development Centre Trust) for the past 12 years to promote higher education among the less fortunate young students of the coastal belt sponsored by Rev. Fr. Jan Vriend from the Netherlands. Fr. Vriend has an ecclesiastical and ecumenical philanthropy to help the poor and downtrodden.

Cape Comorin Trust was formed with the aim of education and charity. The Founding President is Dr. R. S. Regin Silvest.
